From time to time KTAR NEWS 92.3 FM and/or Arizona Sports 98.7 FM (the "Stations") will conduct contests. #### **GENERAL CONTEST RULES:**

1. Contest Dates/Eligibility. Stations may change the dates and/or the terms of the Contest without prior notice.
